ADJUDICATION

BACKGROUND:

This proceeding arises out of a citation that was issued on June 21, 2006, by the Bureau of Liquor Control Enforcement of the Pennsylvania State Police (Bureau) against 3651 Jaquez Enterprises, Inc. (Licensee), License Number R-AP-SS-OPS-9460.

The citation charges Licensee with violations of Section 471 of the Liquor Code [47 P.S. §4-471]. The charge is that on February 9, 14, 17, 23, 24 and March 12, 2006, Licensee's licensed establishment was operated in a noisy and/or disorderly manner.

An evidentiary hearing was conducted on February 5, 2007 at the Philadelphia State Office Building, 1400 West Spring Garden Street, 13th Floor, Room 1, Philadelphia, Pennsylvania. At this time, the Bureau motioned to withdraw the citation. I granted said Motion.

ORDER:

NOW THEREFORE, it is ordered and decreed that Citation No. 06-1513, issued against 3651 Jaquez Enterprises, Inc., License No. R-AP-SS-OPS-9460, is WITHDRAWN WITH PREJUDICE.
